Introducing Mark Lenhard UMC's New President and CEO

United Methodist Communities' new President & CEO, Mark Lenhard, joined the team on October 31. We sat down to discuss his goals for his first year, what excites him about his future with UMC, and his philosophy on fundraising in senior living.

United in Philanthropy: How did you get your start in senior living? What motivated you to take this career path?

ML: I definitely feel this is a calling. As a child, my family was friends with a convent of Carmelite nuns. We didn't have grandparents nearby, so the Sisters were our 45 or 46 great-aunts and grandmothers. The convent had a retired Mother Superior, and all of the novitiates and nuns took turns caring for her. When my siblings and I were there over the summer, we'd help out. That caring aspect felt very comfortable, but it also taught me how people come together in different types of families to care for seniors. I stayed in that social ministry and advocacy area throughout my training and education. I decided that the best way to jump in was through long-term care, and I became a licensed nursing home administrator.

UiP: Do you have a favorite area of senior care?

ML: I wouldn't say I have a favorite, but my engagement with hospice has been the most life-changing. In hospice, a lot of society's politics, drama, and constraints are put to the wayside to focus on engaging and connecting. There is a sense of legacy, passing on history, and sharing the core of who a person is. It's a very unvarnished glimpse of a person's soul, and I've found it to be the most impactful.

UiP: You've shared that faith-based nonprofits have a "breadth of soul" that you enjoy engaging with. What attracted you to UMC, specifically?

ML: Two things – UMC is a great comfort because it's very similar to the Wesleyan tradition I've come from.

At the same time, I also liked the expansiveness of the ministry: independent living, assisted living, memory care, skilled nursing, home care, and senior housing apartments. UMC's ministry helps people across the spectrum, and the board is committed to supporting the Gift of Care. UMC has the whole package, and our responsibility is to serve the whole person.

UiP: Now that you've been with UMC for several months, you've had the opportunity to visit all of the communities and get to know residents and teammates. What has you most excited?

ML: Across the teammates, residents, and board members, there is a hunger and excitement for coming out of the crisis of covid and going into a time of growth. We also recognize the need to be good stewards of our resources, including our human resources. I'm very excited about telling the story of the excellent work UMC is doing. Creating strong connectivity through transparent communication is a goal for my first year with UMC. First, connecting internally as teammates and board members, then taking that story to the wider communities and finding new ways to partner and reach people who have been unreachable in the past. It's not about tooting our own horn; it's about taking our message out into the world.

From a more personal perspective, Thanksgiving was very exciting because I spent it with some of our residents. They were very warm, welcoming, and tolerant of my use of the word y'all. I met several residents who know bishops and ministers that I worked with in Texas, and one gentleman I sat down with was a retired professor from Rice University who was in the same field of study as one of my sons.



UiP: You've said that in a nonprofit, mission-driven organization, everyone is a fundraiser. That can be scary for some people to hear. Can you elaborate on that philosophy?

ML: To support seniors, especially in times when they don't have dollars, we have to be able to raise funds. I say everyone is part of that because, at the end of the day, it is the housekeepers, the CNAs, the maintenance workers, the community life assistants, the receptionists, etc., who have the most hands-on time with residents. Those teammates do little things that go the extra mile in making their community feel like family, and the gifts we receive from residents and residents' families are expressions of gratitude and thanks for that type of work.

When a grateful family member says, "I really appreciate what you've done for me; what can I do to help?" that family is expressing they want to have an impact. When teammates recognize that and can provide information or connect them to the Foundation, they are helping those families make an impact.

UiP: What message would you like to share with our donors and readers?

ML: It's a very exciting time for UMC. It's absolutely essential that we continue to grow the health of Gift of Care so we can increase the number of lives the fund impacts. Gift of Care wouldn't be possible without the support of generous donors. I want our donors to see and hear that they aren't just investing in subsidized care for people who don't have the finances; they are enhancing the quality of life and care and creating opportunities for connection.

Additionally, I see an opportunity for UMC to have a presence serving our veterans. I don't know what the expression is going to be, but we are thinking about how we can take the work we've done and provide services to veterans who would otherwise not have access.

UiP: And finally, what does "abundant life" mean to you?

ML: Abundant life is connectivity to others. It's the continued growth and enhancement of what home means to you.

WHAT'S A QCD CGA?

Recent legislation permits you to make a onetime qualified charitable distribution (QCD) of up to \$50,000 directly from your IRA to a charity like the UMC Foundation to establish a new charitable gift annuity (CGA). This is a way to reduce your overall IRA value, generate lifetime income, and support your community's future.

This one-time QCD is included in any annual QCDs that you may already be making, and there is still a \$100,000 maximum. There are some slight differences between the new CGA QCDs and traditional CGAs:

- You can make this election in one tax year only
- There is an aggregate limit in that year of \$50,000
- The entire gift annuity payment will be fully taxable
- It can be for you and/or your spouse
- There is no charitable deduction

As an additional benefit, the CGA payment rates increased on January 1, 2023. Here are the current rates:

Age	Payment Rate
75	6.6%
80	7.6%
85	8.7%
90	9.7%

However you choose to fund a CGA, a Charitable Gift Annuity with the UMC Foundation creates stable, fixed income for your lifetime. At maturity, the balance of your CGA with the UMC Foundation benefits our mission of compassionately serving seniors

SECURING SAFETY AND QUALITY OF LIFE – New Jersey Nonprofit Security Grant Program

We are excited to share that United Methodist Communities at Collingswood has been selected as a recipient of the 2022 New Jersey Nonprofit Security Grant Program.

The State of New Jersey Office of Homeland Security and Preparedness administers this program and reimburses security personnel and equipment for nonprofit organizations at risk of terrorist activity. Per guidance from the federal Department of Homeland Security, faith-based organizations remain at higher risk. UMC at Collingswood's proximity to public parks, schools, police, and transportation hubs also made the community an excellent candidate for the program.

The \$50,000 grant will be used to completely modernize the CCTV capabilities at UMC at Collingswood and help ensure our residents and teammates' safety and quality of life. The smart boundary technology and advanced recognition capabilities of the cameras UMC's IT department has selected will not only secure our perimeters and minimize risk, but also assist with compliance, facial recognition, contact tracing, and improve environmental management efficiencies.
